## **Contract Specifications**

Description	Contracts are financially settled based upon the price of coal delivered into the Amsterdam, Rotterdam region in the Netherlands, and Antwerp region in Belgium. The contract is cash settled against the API 2 Index published in the Argus/McCloskey Coal Price Index Report.
Contract Symbol	ATW
Contract Series	Up to 84 consecutive month contracts.
	25 to 28 consecutive quarters. Quarters are strips of three individual and consecutive contract months. Quarters always comprise a strip of Jan-Mar, Apr-Jun, Jul- Sep or Oct-Dec.
	6 consecutive seasons. Seasons are strips of six individual and consecutive contract months. Seasons always comprise a strip of Apr-Sep or Oct-Mar.
	6 consecutive years. Years are strips of twelve individual and consecutive contract months comprising Jan - Dec.
	Months, quarters, seasons and years are listed in parallel. Upon expiry of a December monthly contract an additional 12 months, four quarters, two seasons, and one calendar year are added.
